This is in reference to your application no. 0125191231400197 dated 10-09-2023 regarding the Renewal Fire Safety Certificate of an existing educational institution comprising two nos. block i.e. BLOCK- A :- G+IV Storied building and BLOCK- B:- G+II storied building in the name & style of "VIVEKJYOTI COLLEGE" under group of educational occupancy at the premises of PO - UTTAR MECHAGRAM, PANSKURA, DIST - PURBA MEDINIPUR, PIN - 721139, JL NO - 74, DAG NO - 1006, KHATIAN NO – 494,

The performance of the Fire Fighting System as incorporated in the buildings were tested at random and found satisfactorily working condition. In view of the above this office is releasing the Renewal of Fire Safety Certificate for occupancy of the aforesaid building.

However to up-keep the Fire Safety Measure of the aforesaid building the following safety measures need to be incorporated / maintained.

Recommendation:

Conditional Renewal fire safety Certificate allow, subject to,-

- 1. As exceed the floor area (over 1000 sq.mtrs.), provide another Down comer at another stair case.
- 2. Provide Stand by pump as same capacities of main Pump and should be driven by auto mode.

Comply the above conditions with in Three months from the date of issuing of this Certificate and inform to this end by written with photograph positively to regularization the Certificate.

However, to up-keep the Fire Safety Measure of the aforesaid building the following safety measures need to be

incorporated / maintained.

- 1.All the Fire Safety Recommendation which was issued by this office vide memo no.- WBFES/1091/16/Purba Medinipur-EB/111/16(111/16) DT.- 09.02.2016, to be followed strictly at all time.
- 2.Another one fire pump with same capacity of main fire pump preferably diesel driven type shall have to be installed as an alternative.
- 3.Driveway must be free from any type of obstruction for easy movement of fire appliances. No parking will be allowed on the driveway.
- 4. The interior finish decoration of building shall be made with low flame spread material confirming to the I.S. Specification.
- 5.To eliminate risk of fire hazards, Good House Keeping both for inside and outside of the building shall be strictly
- 6. Electrical wiring of the whole building shall have to be carefully checked for any wire and tear in them, Particularly lines above false ceiling & ducts. Electrical safety Audit to be conducted positively by 31st March in every year.
- 7.A fire control room including a CCTV system will have to be maintained, which observe all floor of the building.
- 8. The notice of fire fighting and Evacuation from the shall be prepared and displayed at all venerable of the building.
- 9. The employees and security staff, shall be conversant with installed Fire Fighting equipment of the building and to operate in the event of fire and testing.
- 10. Mock fire practice and evacuation drill shall be performed periodically with participants of all the occupants of the building.
- 11.Electrical installation room shall be protected with automatic CO2 or D.C.P. Fire extinguishers confirming I.S. Specification.
- 12.Unauthorized cooking arrangement in any floor of the hotel building except kitchen by using L.P.G., Kerosene etc. shall not be permitted and Fire License shall have to be obtained for storing and processing with L.P.G. and other highly combustible articles.
- 13. Arrangement shall have to be made for regular checking, testing and maintenance of all fire fighting installation in the building to keep them in perfectly good working condition at all the items.
- 14.Periodical flashing of water in the Hose reel hose pipe line shall made to maintain the efficiency working performance of above mention system.
- 15. The fire safety audit to be conducted a regular interval and to be recorded in the fire prevention maintenance register.
- 16. This certificate valid for 03 year from the date of issuance of this certificate.

A renewal certificate is to be obtained in every three year from the Director General, West Bengal Fire & Emergency Services for performance of all the life & fire safety arrangements and installations of the building.
